# **APPLICATION REQUIREMENTS**

- PharmD degree or equivalent experience
- Eligibility for Kentucky pharmacy licensure
- College transcript
- Curriculum vitae
- Letter of intent
- Three letters of recommendation

# PROGRAM COMPLETION REQUIREMENTS

- Attain an "achieved for residency" (ACHR) on 95% of the objectives as assessed by the RPD on the last quarterly evaluation.
  - 100% of the Patient Care objectives (R1.1.1 R1.2.3) must be marked ACHR.
- Participate in at least two (2) medication use evaluations and/or medication policy development [minor project].
- Complete and present one (1) formulary addition to P&T committee.
- Participate in at least two (2) quality improvement projects and/or cost savings initiatives.
- Successfully complete the Marshall University School of Pharmacy Teaching Certificate.
- Complete two (2) research projects designed to improve the services of the department or to achieve a specific research objective [major project].

- One project will be completed as a collaborative effort among all residents and will be presented at ASHP's Midyear Clinical Meeting.
- Individual yearlong projects will be presented at a regional-level conference.
- Prepare and submit a manuscript suitable for publication.
- Prepare and present two (2) ACPE-accredited or equivalent education sessions.
- Participate in the recruitment efforts of the program.
- Complete at least four (4) community and/or professional service activities.
- Complete a minimum of 48 staffing shifts throughout the residency year.
